## Publication of Electricity Tariffs for the Liberia Electricity Corporation (LEC)

This publication is made pursuant to the powers conferred on the Liberia Electricity Regulatory Commission by sections 8,13.4 and 13.7 of the 2015 Electricity Law of Liberia, the Electricity Tariff Regulations 2021, and the Tariff Methodology 2021.

1. The End-User Tariffs (EUT) provided in the table above are the rates and charges payable by all categories of customers within the LEC licensed areas in Montserrado, Margibi, Grand Cape Mount, Grand Bassa, Bomi and Rivercess counties effective January 1, 2026.
2. The energy charge component of the End-User Tariff is set to recover the full revenue requirement of LEC and make a reasonable margin. Costs included in the revenue requirement are operating expenses, depreciation and amortization and return on capital.
3. The fixed charge component of the End-User-Tariff is set to generate additional revenue to fund network reinforcements and quality of service improvements. However, these initiatives must be approved by the Commission.

4. The Commission has approved US\$70.00 (single phase) and Medium Voltage US\$340 (three phase) as a connection charge to be paid by each new customer for their connection to the LEC network in Montserrado, Margibi, Grand Cape Mount, Grand Bassa, Bomi and Rivercess counties.
5. Included in the approved annual revenue requirement of LEC is a surcharge of three-point-five percent (3.5%) of total monthly revenue as Regulatory Levy to cover LERC's regulatory activities in accordance with Section 13.4 of the 2015 Electricity Law of Liberia. This amount must be remitted to the Commission monthly or at such a frequency as established by the Commission.
6. The tariffs are denominated in United States dollars (US\$) and its units.
7. The tariffs may be adjusted by the Commission in accordance with the Minor Tariff Review Principles of the Commission's Multi-Year Tariff Methodology of May 2021.
8. Subject to clause 7, the tariffs shall remain in force until they are reviewed by the Commission.

## Definitions

**End-User Tariff (EUT)** - means the rates per unit of electrical energy and charges payable by customers for electricity supplied.

**Energy Charge** - means the amount charged for energy consumed by customers in kilowatt-hour.

**Fixed Charge** - means monthly fixed charges payable by all categories of customers except Social Tariff customers to recover portion of LEC's network costs.

**kWh** – means Kilowatt-hour
